RESOLUTION NO. 16-65

WHEREAS, the Board of Directors of RIO LINDA COUNTY WATER DISTRICT heretofore initiated a proceeding for the annexation to said District of certain territory designated as "Hein Property Annexation to the RIO LINDA COUNTY WATER DISTRICT (46-65)" pursuant to the District Reorganization Act, commencing with Section 56,000 of the Government Code; and

WHEREAS, the Sacramento Local Agency Formation

Commission by resolution number LAFC-13, approved the proposed annexation subject to the following specified terms and conditions:

- a. Authority for the RIO LINDA COUNTY WATER DISTRICT to annex the territory without notice, hearing or election;
- b. Authority for the RIO LINDA COUNTY WATER DISTRICT to impose an inclusion fee in the amount of ONE HUNDRED FIFTY DOLLARS (\$150.00) per acre as a condition of the onnexation;

NOW, THEREFORE, the Board of Directors of RIO LINDA COUNTY WATER DISTRICT does hereby resolve, determine and order as follows:

(1) The territory designated "Hein Property Annexation to the RIO LINDA COUNTY WATER DISTRICT (46-65)", and particularly described herein be, and the same is hereby annexed to the RIO LINDA COUNTY WATER DISTRICT without notice, hearing or election;

(a) By virtue of the authority granted RID LINDA COUNTY WATER DISTRICT there is imposed on the owners of said property an inclusion fee computed at the rate of ONE HUNDROD FIFTY BOLLARS (\$150.00) per acre as a condition to said annexation.

The exterior boundaries of the territory annexed are described as follows:

All that portion of the Northeast one-quarter of Section /, as shown on the Map of Survey and Subdivision of Rancho Del Paso", recorded March 4, 1911, in Book A of Surveys, Map No. 94, records of said County, described as follows:

Commencing at a point on the North line of said Section 7 and on the conter line of a public road, which point is located West 1330.30 feet distance from the Northeast corner of said Section 7, said Northeast corner of said Section 7 being located at the point of Intersection of the center line of a public road running North and South with the Center line of a public road running North and South with the Center line of a public road running Bost and West; thence from said point of commencement, along the North line of said Section 7, West 174 feet to the Northeast corner of that certain parcel of land conveyed by deed dated August 25, 1952, recorded September 5, 1952, in Book 2270 of Official Records, at page 109, executed by Earl D. Woodruff' to Relph C. Thayer and Lillian P. Thayer, his wife, as joint tenants, thence, along the East line of said parcel of land so conveyed to Ralph C. Thayer and wife, south 260.25 feet to a point on the North line of that certain parcel of land conveyed by deed dated June 26, 1943, recorded June 28, 1948, in Book 1508 of Official Records, at page 131, executed by Earl D. Woodruff to John Ralph Urquhart and Rose Lorene Urquhart, his wife; thence, along the North line of said parcel of land so conveyed to John Ralph Urquharts and wife, East 174 feet to a point on the West line of that certain parcel of land conveyed by deed dated September 4, 1930, recorded September 11, 1930, in Book 314 of Official Records at Page 412, executed by Stella E. LeWald and Harry A. LeWald, her husband, to Anna Ulrich; thence, along the West line of said parcel of land so conveyed to Anna Ulrich, Horth 260.25 feet to the point of commencement. EXCEPTING THEREFROM any portion thereof included within the boundaries of any public highway or road.

One motion made by Mr. Griggs, seconded by Mr. Weber, and unanimously carried, the following resolution was adopted:

RESOLUTION NO. 17-65

WHEREAS, there is presently on deposit in the unappropriated reserve account of both the Water and Sewer Funds \$6,500.00 and \$2,500.00, respectively, which will not be required for District purposes in either of said fund accounts:

AND WHEREAS there is a current need for said funds in the Capital Outlay Account;

BE IT RESOLVED that the amount specified in each account be transfered to Capital Dutlay Account forthwith and that the Treasurer of the County of Sacramento do all things necessary to effect a transfer as aforesaid.

The Board then discussed and criticized the policy of certain employees of the District to accumulate time devoted to District business in excess of forty hours in any one week and thereafter utilize the accumulated time in an extension of their vacations or take leave from their employment at various other times. It was the opinion of the Board that an excessive amount of time has been accumulated by employees in the past all of which when taken by way of leave or extension of vacation could impair the operation of the District. It was the unanimous opinion of the Board that further accumulation of time should be eliminated.

Mr. Griggs moved that the meeting be adjourned. This motion was seconded by Mr. Adams and was unanimously carried.
