The minutes of the regular meeting held on January 10, 1968, were read and approved.

On motion made by Mr. Griggs, and seconded by Mr. Weber, the following resolution was passed and adopted:

#### RESOLUTION NO. 1-68

WHEREAS, the Board of Directors of the RIO LINDA COUNTY WATER DISTRICT desires to initiate a proceeding for the annexation to said District of the territory hereinafter described pursuant to the District Reorganization Act, commencing with Section 56000 of the Government Code;

NOW, THEREFORE, The Board of Directors of the RIO LINDA COUNTY WATER DISTRICT DOES HEREBY RESOLVE AND ORDER as follows:

Section 1 (a) Application and a proposal is hereby made to the Sacramento Local Agency Formation Commission for the annexation of certain inhabited territory to the RIO LINDA COUNTY WATER DISTRICT. The exterior boundaries of such territory are described as follows:

> The east 125.00 feet of the South 225.00 feet of Lot 10, as shown on "Plat of Elverta", recorded in the office of the County Recorder of Sacramento County, January 23, 1908, in Book 8 of Maps, Map No. 40. The subdivision of said lot being made on the basis that the Lot area is computed to the center of the adjoining roads.

- (b) It is desired that the proposed annexation provide for and be made subject to the following terms and conditions:
  - Authorization for the annexing District to annex the territory without notice and hearing and without election.
  - 2. Authorization for the annexing District to impose an inclusion fee of \$150.00 an acre.
- (c) The reason for this proposal is to secure the services of the District.

Mr. Griggs moved that the Treasurer of the County of Sacramento be authorized and directed to pay out money of the District in the total sum of \$5,234.09 from the Water Maintenance and Operations Fund and in the total amount of \$1,009.73 from the Sewer Revenue Fund, as represented by request for warrants numbered W2266 through 2288 and \$1661 through \$1679, respectively, and as represented by fund schedules dated February 14, 1968, all of which requests and schedules have been signed by the president and countersigned by the secretary and signed by a majority of the Board of Directors. This motion was seconded by Mr. Eia and was unanimously carried.

The chairman then called the Board's attention to a letter proposed to be sent to the Spink Corporation which was drafted by the District's Secretary and represented a response to the Spink

Corporation's letter of inquiry dated January 25. An evaluation of the contents of the letter and the benefits that will accrue to the District were made and discussed and on motion by Mr. Griggs, seconded by Mr. Chapman, the Secretary of the District was authorized and directed to forward the proposed response to the Spink Corporation.

WHEREAS, the Rio Linda County Water District has on deposit with the Treasurer of the County of Sacramento, \$40,000.00 which will not be used or required by the District for the purposes for which it is intended for an extended period of time; and

WHEREAS, it is the desire of the Board of Directors of said District to invest \$40,000.00 in United States of America treasury bills maturing in ninety or ninety-one days from the date of purchase.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Rio Linda County Water District as follows:

- (1) The County Treasurer of the County of Sacramento is hereby authorized and requested to purchase at the offered price approximately \$40,000.00 worth of United States of America treasury bills through his agent at the first offering date by the Federal Reserve Bank.
- (2) Said County Treasurer is further authorized and requested to have the said United States of America treasury bills held for safe-keeping in San Francisco, California, for the account of the Distroct.
- (3) The County Auditor of Sacramento County, California, is hereby authorized and requested to do such things as may be necessary

to effect the objects and purposes of this resolution.

Mr. Ela moved that the president and secretary be authorized and directed to enter into a contract for the furnishing of water for Faith Temple Church of Deliverance, a corporation sole, providing for water rates as follows: for the first 1,000 cu. ft. or less \$4.00; for the next 6,000 cu. ft., \$2.00 per 1,000 cu. ft. and for all over 7,000 cu. ft. at the rate of \$1.00 per 1,000 cu. ft.

Mr. Griggs moved that the District purchase a typewriter as proposed by the Assistant-Secretary. This motion was seconded by Mr. Eia and was unanimously carried.

Mr. Richard Copeland submitted his written report for the perlod ending April 30, 1968 and observed that water delinquencies were reduced substantially.

The President reported to the Board on action of the North Area Water Agency and among other things stated that the several water districts in the northeastern area were interested in an engineering study that would cost approximately \$17,000.00. He stated that the various district's share in the overall engineering costs, would be based upon each district's sale of water. He stated that the Rio Linda County Water District's contributive share, if it were to cooperate with the other districts in the engineering study, would be approximately \$424.00 to \$495.00. Mr. Griggs and Mr. Eia expressed their opposition to the Rio Linda County Water District entering into any agreement with the other districts.

On motion duly made, the meeting was declared adjourned.

The Board then considered salary adjustments as recommended by the District Manager in the positions of: forman, maintenance and operations; office manager and assistant secretary to the Board; maintenance mechanic; and junior maintenance mechanic. It was unanimously agreed by the members of the Board that the suggested salary adjustments as submitted to the Board by the District Manager be increased in each instance by \$25.00 per month, thus resulting in payment commencing July 1, 1968 of \$725.00 for the forman, maintenance and operations; \$650.00 for the office manager and assistant secretary to the Board; \$625.00 to the maintenance mechanic and \$575.00 to the junior maintenance mechanic. On motion by Mr. Eia seconded by Mr. Griggs that the salary increases as discussed by approved and become effective July 1, 1968. This motion was seconded by Mr. Griggs and was unanimously carried.

Mr. Chapman moved that the salary of Harry H. Wagner be increased to the sum of \$1,050.00 per month commencing July 1, 1968.

Mr. Griggs seconded said motion which motion was unanimously carried.
